

**Dispatch Service Work Agreement**

Payment will be due to Truck It Transport Inc every Monday for all loads dispatched the previous week. If no payment is received, no dispatch will be done until payment is received. All checks will be made payable to Truck It Transport Inc. In the case of a returned check and \$30 fee will apply and no dispatch will be done until check is made good.

I understand that I must furnish Truck It Transport Inc with the following documents:

- W-9
- Insurance Certificate listing Truck It Transport as a Certificate Holder (Minimum Insurance required is \$150k Cargo and \$1 Million Liability for 3-4 car carriers.)
- Motor Carrier Certificate.
- Login and Password for Central Dispatch
- Copy of the BOL you will be using
- Type of Truck and Trailer you will be using
- Mailing address and contact information

Truck It Transport will be responsible for Dispatch and any necessary paperwork needed to set up accounts with brokers. Either Candice or Chris Cooper has authority to sign on behalf of the above stated company to set up accounts.

All dispatch will be done through email or text messaging if no wireless internet is available. Truck It Transport will NOT be responsible for calling pick up and drop off locations to make arrangements.

Billing is optional for a 2% fee. All invoicing and a monthly report will be provided by Truck It Transport. Signed Bill of Ladings must be emailed or faxed to Truck It Transport Inc in order to send invoices for payment. Invoices will be faxed for billing the same day BOL's are received by Truck It Transport Inc.

This Agreement supersedes any prior written or oral agreements between the parties. Amendments to this agreement must be made in writing and signed by both parties to be binding on either party.
